

A Clear Conservative Choice for Indiana Senate District 22

Defending Families, Upholding Rule of Law, and Preserving Conservative Integrity

Executive Summary

Indiana families deserve a senator who consistently protects children, strengthens families, supports parental rights, and upholds conservative values.

A review of Senator **Ron Alting's recent voting record** shows repeated alignment with policies and votes that:

- Undermine parental authority
- Fail to adequately protect children
- Accommodate government expansion into family decisions
- Oppose core conservative reforms
- Diverge from Republican majority positions on immigration and election integrity
- Support legislation such as **SB 296** granting driving privilege cards to those unable to document lawful status

This white paper documents those votes and actions, presenting voters with a clear record-based contrast — and a conservative path forward.

I. Immigration, Election Integrity, and Rule of Law

HB 1264 (2024) — Election Integrity Bill

Strengthened residency verification, data cross-checks, and county election confidence.

Sen. Alting voted AGAINST it.

He joined Democrats and three Republicans opposing the GOP election security bill.

HB 1393 (2025) — Immigration Enforcement

Required jails to notify federal authorities when individuals arrested are likely unlawfully present.

Sen. Alting voted AGAINST it.

SB 296 (2025) — Driving Privilege Cards

Created *driving privilege cards* for undocumented residents lacking lawful status documentation.

- Introduced January 30, 2025
- **Senator Ron Alting served as a Co-Author**

While the bill died in committee, co-authorship signals clear policy support.

II. A Troubling Pattern on Children and Families

The strength of a conservative senator is best measured by how they vote when families need protection, children need safeguarding, and parents need defending.

On multiple defining family-focused bills, Senator Alting sided **against conservative families**.

According to the compiled legislative voting record:

Anti-Alting Page-2 (1)

A. Votes Opposing Protection of Girls' Sports

HB 1041 — Protecting Female Athletics

Prohibited biological males from competing in girls' athletics.

Sen. Alting VOTED NO.

He voted **against protecting girls' sports**, against biological fairness, and against conservative family standards.

B. Votes Opposing Parental Rights and Childhood Protection

HB 1608 — Restricting Sexualized Content in Grades K-3

Prohibited sexualized instruction in early grades.

He voted NO.

SB 12 — Child Safety Residency Restrictions for Sex Offenders

Strengthened residency protections around children.

He voted NO.

SB 287 — Making School Board Races Transparent and Partisan

Gave families clearer electoral accountability.

He voted NO.

SB 143 — Parental Bill of Rights

Affirmed parent authority and transparency expectations.

He voted NO.

C. Votes Supporting School Bureaucracy Over Families

Alting voted **against**:

- Charter school expansion
- Voucher expansion
- Parental complaint process for school library materials
- Ensuring school free-speech climate transparency

Each time, government power won. Families lost.

D. Weakness on Cultural Issues and Family Values

Voting record shows opposition to:

- Marriage protection legislation
- Legislation restricting extremist DEI infiltration
- Protections against LGBTQ curriculum agendas

Each reflects a direction away from conservative family defense and toward appeasing political and institutional forces.

III. Conservative Interpretation

Taken individually, a single vote could be rationalized.

Taken together:

- It is a **pattern**
